

**THE CORPORATION OF THE
MUNICIPALITY OF OLIVER PAIPOONGE**

BY-LAW NO. 419-2006

*Being a by-law to restrict the discharge of firearms
within the Municipality of Oliver Paipoonge.*

WHEREAS Section 119 of the Municipal Act, 2001, Chapter 25, provides that a local municipality may, for the purpose of public safety, prohibit or regulate the discharge of guns or other firearms, air guns, or spring guns, cross bows, long-bows or any other weapon in any defined area or areas thereof;

WHEREAS the Council of the Corporation of the Municipality of Oliver Paipoonge wishes to enact a by-law for the purpose above mentioned, for the protection of public safety;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF OLIVER PAIPOONGE ENACTS AS FOLLOWS:

Prohibited Areas:

1. No person shall discharge any firearm or any class or type thereof; except air operated guns, spring guns, cross bows and long bows, within the Municipality of Oliver Paipoonge in the areas indicated on Schedule A and as described as follows:
 - a) That portion of the former Township of Paipoonge bounded on the east by the City of Thunder Bay; on the south by the Kaministiquia River; on the west by Fraser Drive including the unopened portion thereof which lies south of the former right-of-way of the Port Arthur and Duluth Railway; and on the north by Highway 11-17 also known as Arthur Street.
 - b) That portion of the former Township of Paipoonge bounded on the east by the Kaministiquia River; on the south by Highway 130 and Piper Drive including the unopened portion thereof which lies west of the Kaministiquia River; on the west by Valley Road including the unopened portion which lies south of the Kaministiquia River; and on the north by the Kaministiquia River.

Restricted Areas:

2. No person shall fire or discharge any gun or other firearm or any class thereof except a shotgun (whether loaded with slugs or pellets) or an air operated gun, spring guns, cross bows, long bows within the Municipality of Oliver Paipoonge in the following areas:
 - a. Those areas in the former Township of Oliver described as "Kakabeka Falls" on Schedule "B" of the Official Plan map of Oliver Paipoonge, including the indicated area designated as "Hamlet" surrounding Kakabeka Falls.
 - b. That part of the former Township of Oliver bounded on the east by the boundary between the Municipality of Oliver Paipoonge and the City of Thunder Bay (Townline Road); on the south by the former boundary between the former Township of Oliver and the former Township of Paipoonge (Poleline Road); on the west by the westerly boundary of Lot 8 in each of Concessions 1,2 and 3 (Mud Lake Road); and on the north by the northerly boundaries of Lots 1 to 8, inclusive, of Concession 3 (John Street Road);

Municipal Owned Lands:

3. No person shall fire or discharge any gun or other firearm or any class thereof including shotguns, air operated guns, spring guns, cross bows and long bows in the following:
 - a) All lands owned or administered by the Corporation of the Municipality of Oliver Paipoonge, including areas within 100 metres of Spence Road and Barrie Drive waste disposal sites.
 - b) On or across any portion of a municipal road allowance.
4. **Exceptions to this by-law:**
 - a. That the provisions of this by-law shall not apply to any person in a bona fide attempt to protect livestock, persons or property, provided such discharge is reasonably necessary and otherwise lawful.

- b. That the provisions of this by-law shall not apply to any peace officer or any member of Canadian armed forces, or other official, when duly authorized and in the actual and bona fide performance of his duties.
 - c. That the provisions of this by-law shall not apply to any club or organization that receives written approval, through the CAO as directed by Council to discharge firearms within the prohibited areas.
 - d. The Council for the Municipality of Oliver Paipoonge may by resolution permit activities otherwise prohibited by this by-law upon terms that are set out in the resolution.
5. Any person convicted of a breach of any of the provisions of this by-law shall be subject to a penalty not exceeding \$ 2,000.00 for each offence and the provisions of the Provincial Offences Act shall apply to the recovery of such penalty.
 6. This by-law shall be enforced by Peace Officers in the Province of Ontario or any Provincial Offences Officer.
 7. That this by-law shall come into force and take effect upon the final passing thereof.

By-laws 796-1987, Township of Oliver and 1108-90, 903-85, Municipality of Paipoonge are hereby repealed.

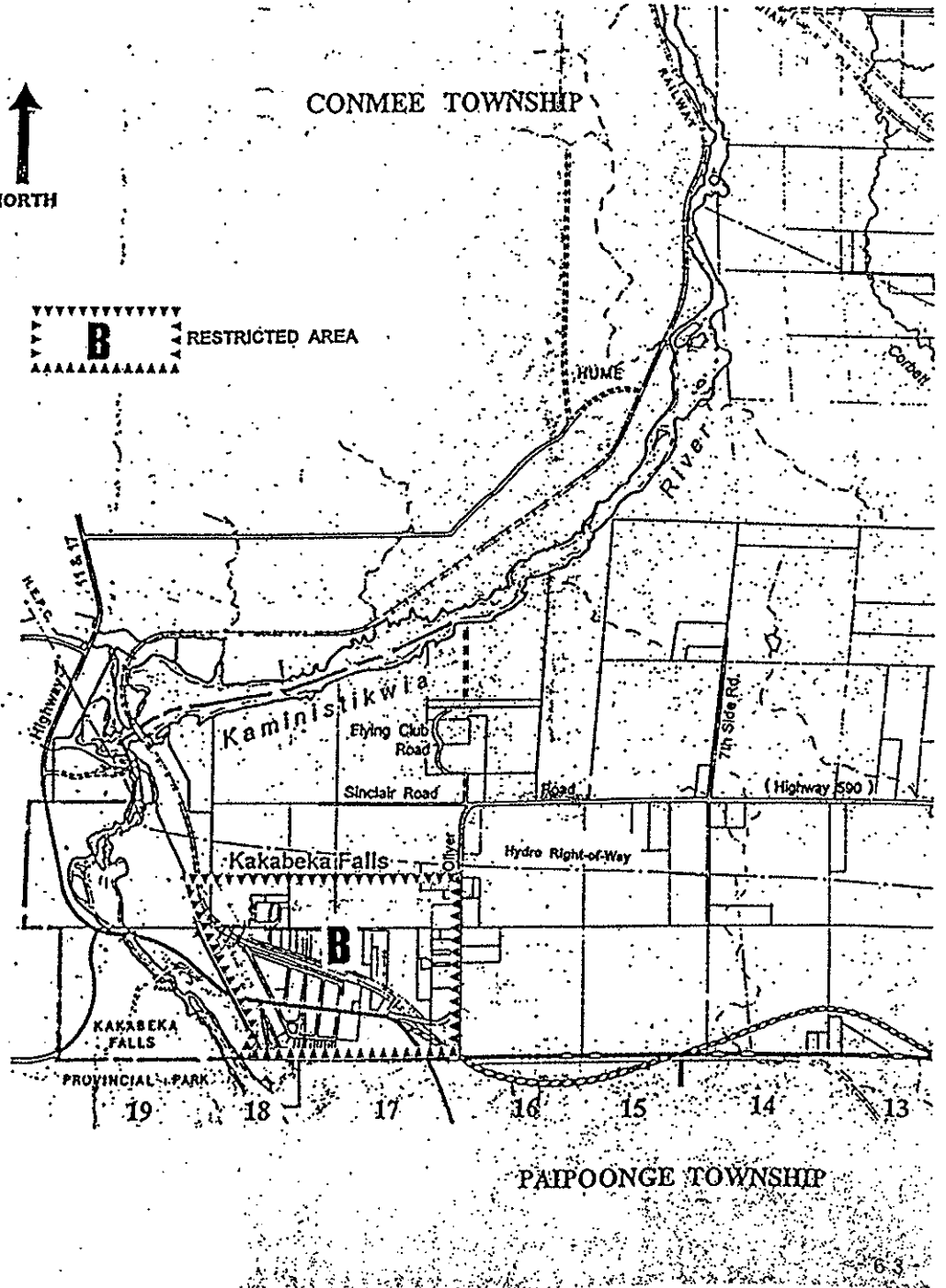

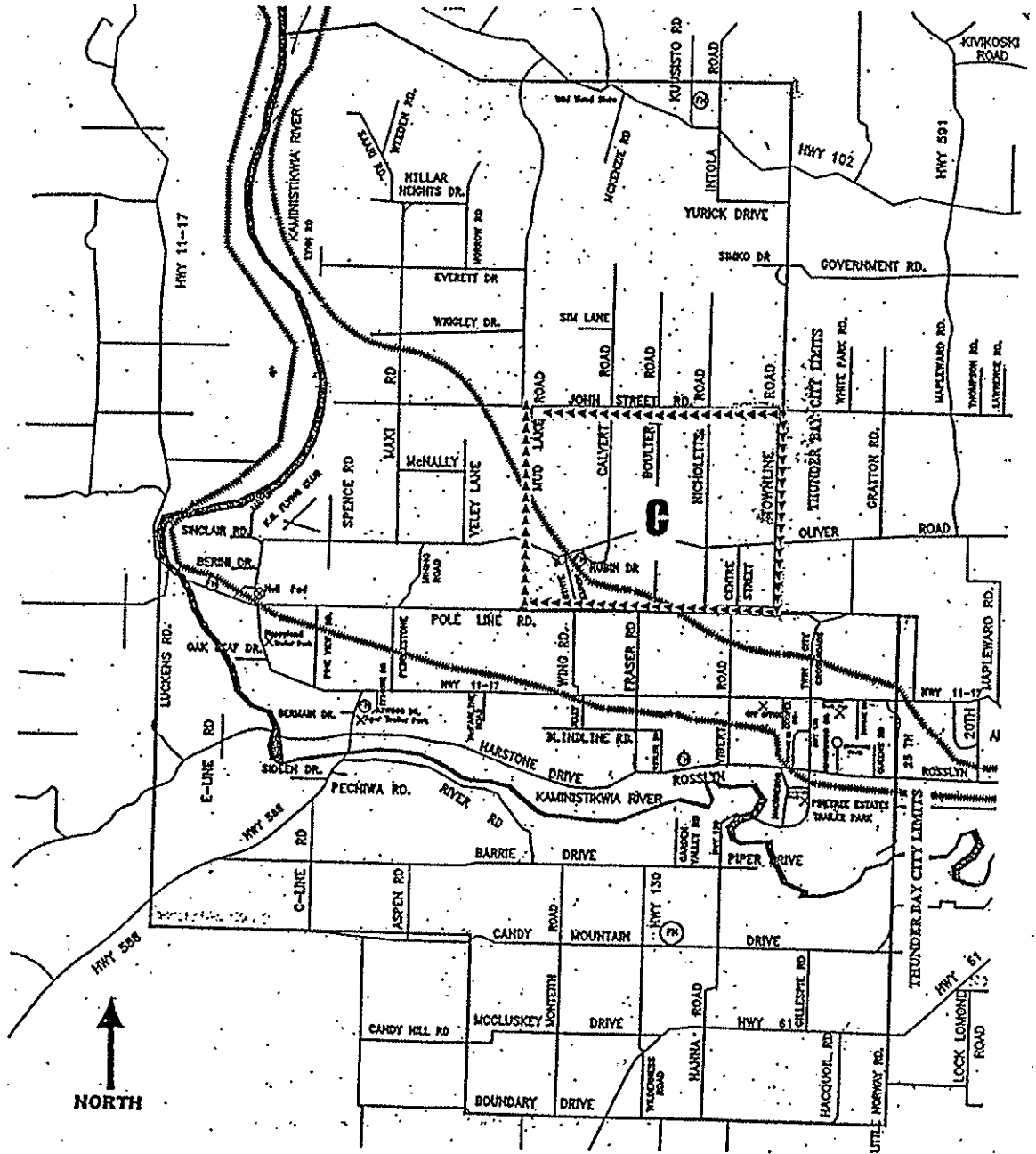
MUNICIPALITY OF OLIVER PAIPOONGE

B RESTRICTED AREA

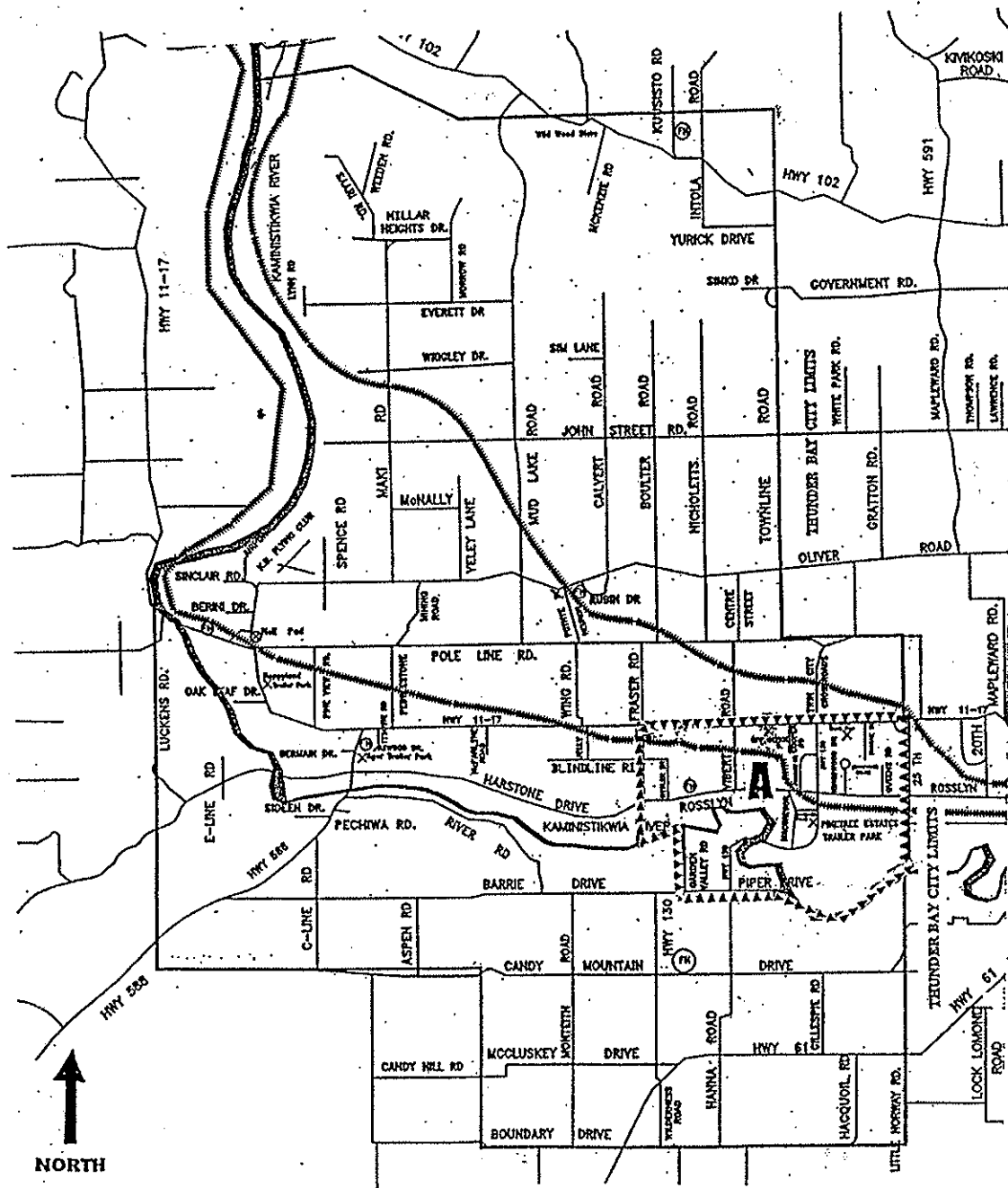


VILLAGE OF MURILLO
